In terms of the resolutions of the Syndicate of the University of Calcutta dt. 10.04.2007 (item no. 26) and the undertaking submitted by the Parameswar Mahavidyalaya (B.Ed., Self-Financed) vide letter no. PM/26/2007 dt. 16.04.2007 in response to the University letter no. 18/UCAC/CU dt. 13.04.07 for considering the following course in one(1) year B.Ed. degree (self-financing).

Course	Intake	Session
B.Ed.	100	2007-08

Parameswar Mahavidyalaya (B.Ed., Self-Financed) is hereby accorded the provisional affiliation for three(3) years subject to the fulfillment of the following terms and conditions. Any infringement / contravention / non-compliance of these conditions may lead to withdrawal of the affiliation.

**ATTESTED**

1. Teachers, Non-teaching Staff including the Principal are to be appointed strictly according to the norms prescribed by the NCTE in its notification dated 21<sup>st</sup> July, 2006. Those who are yet to qualify in NET or SLET or its equivalent but qualified otherwise may be appointed temporarily only on condition that they acquire the necessary qualification before commencement of the academic session 2009-10.
2. Library books are to be purchased as per requirement of the B.Ed. syllabus before commencement of the session 2007-08.
3. Method papers to be allowed shall depend upon the final list of teachers appointed for teaching these papers which is to be submitted to the Vice-Chancellor at the time of seeking permission to admit students.

4. As per the NCTE Notification No. F. 49-42/2005-NCTE (N&S) published in the Gazette of India (Extra ordinary) Part III, Section 4, dated 13.01.2006, the institution appears to have fulfilled the conditions 8(5), 8(6), 8(7) and 8(8). But the institution is further required to obtain permission from the Vice-Chancellor for admission of students.

5. The institution should abide by the conditions in clause 8(1) and all the authorities mentioned in the clause 8(12).
6. Records and Registers are to be maintained as per the clause 8(13).
7. The College authority is required to submit a report of compliance of conditions as mentioned in the letter of affiliation and also on compliance of admission of students strictly on merit basis.
8. The "Organising Committee" has to be replaced by a "Governing Body" which is to be specified by (i) composition (ii) Office bearers, (iii) Names of the Office bearers and members, (iv) their mode of election/selection/nomination as per prevailing rules and norms of the University and/ or Government of West Bengal.
9. The institution shall keep regular contact with the Secretary, Faculty Council for P.G. Studies in Education and P.G. Board of Studies for necessary administrative and academic matters and maintain high quality academic standard of the University Calcutta. The college will initiate orientation of the newly appointed teachers so that the above mentioned standard in respect to the B.Ed. course is maintained.


